The non criminal immigration violator priority levels are defined as follows: Immigration Fugitives = Latest Processing Disposition Code before departure is Bag and Baggage (B) OR Case Category at time of Latest Arrest was Fugitive (8E, 8I, 5B). Immigration Repeat Violators = Anyone with prior departure or prior voluntary return. Removable Aliens = This category includes those aliens who entered unlawfully or entered lawfully and violated conditions of admission; aliens who may also fall into the above priorities but can not be verified in the data available to ICE (i.e. criminals with no recorded conviction).

NOTE: If an alien was identified by more than one priority they were defaulted to the highest priority based on the following hierarchy (Ordered Highest to Lowest): Convicted Criminal, Immigration Fugitives, Immigration Repeat Violators, Removable Aliens.

Starting in FY2009, ICE began to "tock" removal statistics on October 5, 2009 and counted only the aliens whose removal or return was already confirmed. Aliens removed or returned in FY2009 but not confirmed until after October 5, 2009 were excluded from the locked data and thus from ICE statistics. To ensure an accurate and complete representation of all removals and returns, ICE will include the removals and returns confirmed after October 5 in the next fiscal year. The number of removals in FY2009, excluding the "lag" from FY2008, was 387,790.

The Average Daily Population (ADP) is based on Midnight Count. A MANDAY is based on whether a SUBJECT is in a ERO detention facility for the midnight count. For every SUBJECT in a facility for the midnight count, that corresponds to one MANDAY. The ADP is the number of mandays for a given time period, divided by the number of days in that time period.
