The Average Daily Population (ADP) is based on Midnight Count. A MANDAY is based on whether a SUBJECT is in a ERO detention facility for the midnight count. For every

SUBJECT in a facility for the midnight count, that corresponds to one MANDAY. The ADP

is the number of mandays for a given time period, divided by the number of days in that time period.

Facilities Montgomery County and Joe Corley Detention Center were requested. These facility names are different names for the same facility and have been reported as such.
