INDICTMENT

The Grand Jury Charges:

<u>Count One</u> Attempted Enticement of a Minor (Violation of 18 U.S.C. § 2422(b))

From on or about April 20, 2012, through on or about April 24, 2012, in the Dallas Division of the Northern District of Texas, and elsewhere, defendant, **Andrew Dale McKee**, using the Internet and a cellular telephone, facilities and means of interstate and foreign commerce, knowingly attempted to persuade, induce and entice Jane Doe, a 14year-old girl, to engage in sexual activity for which the defendant could be charged with a criminal offense, specifically a violation of Sec. 22.011, Texas Penal Code, that is, Sexual Assault of a Child, which makes it a crime to intentionally and knowingly engage in sexual intercourse, and other enumerated sex acts, with a child under 17 years of age.

In violation of 18 U.S.C. § 2422(b).

Count Two Transfer of Obscene Material to a Minor (Violation of 18 U.S.C. § 1470)

On or about April 23, 2012, in the Dallas Division of the Northern District of

Texas and elsewhere, the defendant, **Andrew Dale McKee**, using a cell phone, a facility and means of interstate and foreign commerce, knowingly transferred, and attempted to transfer, obscene matter to an individual whom he knew had not attained the age of sixteen years, by sending, via text message, to Jane Doe, a 14-year-old girl, the following described image, which is lewd, lascivious, and obscene:

Description	A still image file depicting the close up view of an adult penis
	touching (preparing to penetrate) the exposed opening of a vagina.
	An unknown individual's fingers (painted fingernails) can be seen
	spreading the lips of the vagina to expose its opening.

In violation of 18 U.S.C. § 1470.

<u>Count Three</u> Attempted Enticement of a Minor (Violation of 18 U.S.C. § 2422(b))

From on or about April 24, 2012, through on or about April 26, 2012, in the Dallas Division of the Northern District of Texas, and elsewhere, defendant, **Andrew Dale McKee**, using a cellular telephone, a facility and means of interstate and foreign commerce, knowingly attempted to persuade, induce and entice an individual whom he believed to be a 14-year-old girl, to engage in sexual activity for which the defendant could be charged with a criminal offense, specifically a violation of Sec. 22.011, Texas Penal Code, that is, Sexual Assault of a Child, which makes it a crime to intentionally and knowingly engage in sexual intercourse, and other enumerated sex acts, with a child under 17 years of age.

In violation of 18 U.S.C. § 2422(b).
