INDICTMENT

The Grand Jury Charges:

Count One

Receipt of a Visual Depiction of a Minor  
Engaging in Sexually Explicit Conduct, and Aiding and Abetting  
(Violation of 18 U.S.C. §§ 2252(a)(2) and 2)

Between on or about August 21, 2011, and February 10, 2012, in the Amarillo Division of the Northern District of Texas, and elsewhere, **Anthony Zane Austin**, defendant, did knowingly receive, and attempt to receive, a visual depiction using the Internet, a means and facility of interstate and foreign commerce, the producing of which depiction involved the use of one or more minors engaging in sexually explicit conduct, and which visual depiction was of such conduct.

In violation of Title 18, United States Code, Sections 2252(a)(2) and 2.

Count Two

Possession of Child Pornography and Aiding and Abetting  
(Violation of 18 U.S.C. §§ 2252A(a)(5)(B) and 2)

On or about April 26, 2012, in the Amarillo Division of the Northern District of Texas, and elsewhere, **Anthony Zane Austin**, defendant, did knowingly possess, and attempt to possess, a 16GB Sandisk thumb drive, serial number 20041101410EE5333, containing at least one image of child pornography as defined in 18 U.S.C. § 2256(8)(A), that had been mailed, shipped, and transported using any means and facility of interstate and foreign commerce, and in and affecting interstate and foreign commerce by any means, including by computer, and that was produced using materials that had been mailed and shipped and transported in interstate and foreign commerce by any means, including by computer.


In violation of Title 18, United States Code, Sections 2252A(a)(5)(B) and 2.


