- During Interim Annuity status, only taxes will be withheld, health & life insurance will not be deducted.
- Annual/Sick Leave will not be earned if you separate from service before working the full pay period.
- Medicare or TriCare become primary and FEHB is secondary in retirement.
- TSP withdrawals applications can be made after 30 days after retirement by contacting TSP at <u>www.tsp.gov</u> or call (877) 968-3778.

<u>Law Enforcement Officers (LEOs)</u>: Law Enforcement Availability Pay (LEAP) and AUO (Administratively Uncontrollable Overtime) is included in the high-three average salary computation for LEOs only. LEAP and AUO is also included in the Annual Leave Lump Sum Payment.
