

## Tablet Legal Orientation Program Initiative

ICE, in coordination with the Department of Justice Executive Office of Immigration Review, the Acacia Center for Justice, and tablet providers at select ICE detention with a government funded Legal Orientation Program (LOP), have implemented a Tablet LOP Initiative that enables detained noncitizens to sign up for LOP services, message directly with LOP service providers, and be directed to LOP resources via an LOP Request Form that has been added to the tablets. The LOP Request Form, which is available in 19 languages other than English is available at the facilities below.
