Comments: This inspection was conducted to determine overall compliance with the ICE Performance-Based National Detention Standards 2011 (42 standards), which include the following additions/changes to the standards listed on page three:

- Medical Care (Women), a new standard, was rated Meets Standard;
- Classification System is now titled Custody Classification System;
- Suicide Prevention and Intervention is now titled Significant Self-Harm and Suicide Prevention and Intervention;
- Escorted Trips for Non-Medical Emergencies is now titled Trips for Non-Medical Emergencies;
- News Media Interviews and Tours is now titled Interviews and Tours, and;
- Transfer of Detainees is now titled Detainee Transfer.

During the inspection period, there were fourteen allegations of detainee-on-detainee sexual assault or abuse. Following an investigation of each allegation, three were substantiated; two were unfounded; six were unsubstantiated; and three remain under investigation. There was one allegation of staff-on-detainee sexual assault or abuse "by inappropriate touching during a pat-down search". The allegation was determined to be unsubstantiated. Documentation confirmed chain-of-command reporting, intervention, and investigation within the guidelines of the standard.

There was one reported death which remains under investigation. The facility does not have a canine unit. The only chemical agent authorized for use is OC (oleoresin capsicum)/pepper spray. All security officers have been trained in the application of OC/pepper spray. The use of unsafe types of force such as choke holds, carotid control holds, and neck restraints are prohibited by policy. Tasers are not used.

During this inspection period there were 21 use-of-force incidents; ten of these incidents were calculated and eleven were immediate. Three of the immediate use-of-force incidents occurred while the detainee was in medical isolation. In each case, staff had to take immediate action to prevent the detainee from harming himself or the detainee became aggressive towards staff.

One immediate use-of-force incident occurred in the recreation yard when a detainee was observed climbing over the interior fence. The detainee ignored all orders to stop. The perimeter patrol was notified and when the detainee climbed down from the exterior fence the perimeter patrol officer was waiting for him. The detainee was secured by staff and placed in hand restraints and escorted to the restricted housing unit. This facility determined that this incident was an escape.

There were six incidents in housing units in which staff ordered a detainee to stop unacceptable behavior such as yelling, throwing objects, or being belligerent. In each case, the detainee refused the orders from staff and became aggressive. In one incident a detainee, when being escorted from the restricted housing recreation yard back to his cell, became aggressive and tried to pull away from staff. The detainee was taken to the ground and placed in restraints. After a medical exam, he was returned to the restricted housing unit.

Of the ten calculated use-of-force incidents, four incidents occurred in the restricted housing unit. In nine of these incidents the use of pepper spray was authorized. In one incident, a detainee refused to submit to restraints so that he could be moved to another cell. Repeated attempts to have the detainee submit to restraints were ignored. In two of these four incidents, a detainee covered his window and refused to uncover it. Repeated attempts to have the detainees uncover their windows were ignored. In one incident, the detainee removed the speaker box from the wall and refused to give the speaker box to staff.

Three of the calculated use-of-force incidents occurred while the detainee was on suicide watch. In each of these cases, the detainee refused orders to comply with suicide watch protocol requiring the detainee to remove his clothing.

In one incident, a detainee in medical isolation refused to submit to restraints so that he could be escorted from the medical department back to his cell in the restricted housing unit. A detainee in medical isolation began throwing the bed frame around and threatening staff. The detainee was ordered to stop and the orders were ignored. A detainee placed in a holding cell while being processed into the facility refused to remove his clothing and change into a uniform.

In each of the nine incidents before pepper spray was dispersed, repeated orders seeking compliance were given to the detainees. The cell extraction team was formed and the use of pepper spray was authorized. Decontamination procedures were complied with as required by policy. Medical staff examined each of the detainees. There were minor injuries to detainees. Use-of-force guidelines were followed in each incident.
