Facility Snapshot/Description

The Polk County Adult Detention Center is located on Farm to Market Road 350 South in a rural area of Livingston, TX, approximately one mile from a state prison and sixty miles north of the George Bush Intercontinental Airport in Houston, TX. The facility, which was constructed in 2006, is owned by Polk County and operated by Management and Training Corporation (MTC), a private corrections company. The facility operates pursuant to an IGSA between Polk County and the USMS.

The facility is a one-story building with the secure perimeter surrounded by two, twelve-foot chain link fences both of which are supplemented by razor ribbon. There is a gravel road that encircles the entire compound which is patrolled periodically during daylight hours and routinely during dark hours by armed officers in a vehicle.

The facility has four main hallways on which are located 116 housing units ranging in capacities from four to 24 beds. One hundred-fifteen of the housing units are designated general population housing and one is designated as the special management unit (SMU).

The SMU contains 22 single bed cells, eleven of which are designated for ICE detainees. All housing units receive indirect supervision from roving officers. The primary recreation area is a large outdoor recreation yard. Detainees in general population are offered a minimum of one hour of recreation daily; detainees in the SMU are offered one of hour of recreation five days per week. The housing units each have a dayroom area equipped with a television, telephones and various table-top board games. The entire facility is climate controlled. Although clutter was observed in some of the housing units, cleanliness and sanitation throughout the facility were observed to be average.

The majority of housing units and common areas of the facility used by ICE detainees were visited and/or observed during the inspection. Numerous detainees were interviewed; some interviews were with small groups of detainees and several were private and confidential and included detainees with limited English proficiency (LEP). Language line was used to interview several detainees who spoke neither English nor Spanish. Interviews included detainees who had recently arrived at the facility and some who had been housed at the facility for longer periods of time. The detainees voiced no concerns regarding life/safety issues. Detainees stated they felt safe and were generally satisfied with the interaction, responsiveness and professionalism of facility and ICE staff and with access to medical services, mail, the law library, telephones, visitation and recreation. Detainees expressed general satisfaction with the quantity and quality of food provided although some detainees stated they would like to have larger servings. The safety SME



verified that the quantity of food provided daily meets dietary requirements and has been certified by a registered dietitian. Some of the non-English speaking detainees from Central America complained that officers had a tendency to raise their voices when the detainees were unable to understand their instructions. This issue was discussed with the OIC, assistant OIC and the chief of security; all of whom were aware of the issue and stated they have been proactively working with staff regarding communications with non-English speaking detainees.

Detainee telephone services are provided by NCIC Inmate Communications. Medical services are provided by MTC Medical; a division of MTC. The commissary vendor is Lone Star. All other services are provided by MTC.

ICE detainees do not incur medical co-pays at this facility.

Areas of Concern/Significant Observations

There were no areas of concern or significant observations.

Recommended Rating and Justification

The Lead Compliance Inspector recommends that the facility receive a rating of Acceptable. The facility complies with the ICE National Detention Standards. No (0) standards were found Deficient and one (1) standard was Not Applicable (N/A). All remaining thirty-eight (38) standards were found to be in compliance.
