Comments: The Sexual Abuse and Assault Prevention and Intervention Standard was inspected during this inspection but is not referenced in the Standards Review Summary Report. The Standard was rated as Meets Standard for this inspection.

There were six allegations of sexual assault or abuse involving an ICE detainee during this inspection period. One detainee reported repeated sexual harassment by another detainee. Following an investigation, the incident was determined to be unfounded. A second detainee reported sexual harassment by another detainee; the incident remains under investigation. There was one reported incident of abusive sexual contact which remains under investigation. There were three incidents of non-consensual sexual acts; all three remain under investigation.

There were no escapes, deaths or serious suicide attempts during the inspection period. The facility does not use Tasers and does not have a canine unit for contraband detection. The only chemical agent authorized for use at the facility is OC (oleoresin capsicum)/pepper spray. The use of unsafe types of force such as choke holds, carotid control holds and neck restraints are not authorized.

During this inspections period there were five use-of-force incidents; two immediate/spontaneous uses of force and three calculated.

One of the immediate use of force incidents was found to be unjustified. During count, an officer pinched the nose of a detainee to get his attention. The incident was reported by the detainee and the second officer conducting the count. The incident was investigated and as a result of the findings, disciplinary action was taken against the officer. Details regarding the other four uses of force are found in the end remarks of the Use of Force standard checklist. As a result of these five use-of-force incidents there were no injuries to staff or detainees and chemical agents were not used. A review of documentation revealed that various documents maintained in the use of force file for each incident were incomplete, some signatures were missing and various boxes were not marked as required. There was one video recording of a calculated use of force incident; however, the quality of the video recording was so poor that an evaluation of the use of force techniques could not be made. The facility was unable to locate video recordings of the other two calculated use-of-force incidents. As required by policy, all incidents were reviewed by senior management and ICE was notified of the uses of force.
