Type of Inspection

Facility Snapshot/Description

The Adelanto ICE Processing Center West is located in the high desert southwest region of Adelanto, California, neighboring other correctional facilities and government buildings. The facility is owned and operated by the Geo Group, Inc.; as is the adjacent facility, Adelanto ICE Processing Center East. The Geo Group has an intergovernmental services agreement with ICE and the City of Adelanto, California. The facility is a Dedicated IGSA housing male ICE detainees of all classification levels under the direct supervision model. [REDACTED]

Detainees are housed in sixteen cellblocks in two- or four-person cells situated on upper and lower ranges in each housing unit. There is a segregation unit as well. The entire building is air-conditioned. The housing units have dayrooms with televisions, video games, board games, and telephones. Attached to each unit is an outdoor recreation area which detainees may use up to six hours per day, seven days per week, resulting in optimal compliance for the outdoor recreation requirements. Detainees are offered additional recreation on a large centralized outdoor recreation yard for at least one hour per day. Each housing unit is equipped with two kiosk computers loaded with the LexisNexis program available to detainees every day during waking hours as well as two stand-alone law libraries providing optimal compliance in regards to access to legal services.

The atmosphere was relaxed throughout the facility and detainees were observed interacting with one another and recreating for the most part. Staff and detainees interact informally and without apparent hesitation. Staff are professional in appearance and tend to be informed regarding the standards as related to their individual duties. A significant percentage of the staff are bilingual.

The inspection team conducted no less than eighty detainee interviews; 23 of which were formal interviews. One detainee stated that an officer had made a sarcastic comment to him. He did not file a complaint or a grievance. The inspector suggested that he do so if he wanted the complaint investigated. Five detainees complained that they did not like the food and one detainee stated that the meal portions were too small; yet another did not like the menu variety. The Safety SME confirmed that the menu was approved by a dietician; that the serving size of food portions met the minimum daily requirements; and that the menu had sufficient variety for the demographics of the detainee population. One detainee stated that there were ventilation problems and a lack of air conditioning in the housing units. The Safety SME confirmed that the ambient temperatures in the housing units were within the guidelines of the standards. One detainee complained of mold in the showers. Every shower in the facility was inspected and one individual shower had a small patch of mildew on the ceiling; and upon notification of the findings, the facility took immediate action to eradicate the mildew. One detainee complained that an x-ray was overdue. The Medical SME checked and determined that the medical department had not ordered the x-ray as intended; the facility then scheduled the x-ray for the next day. Three detainees complained of miscellaneous medical issues and all were under current, active care of the health services department with their conditions being addressed. Without exception, detainees stated that they felt safe at this facility and
