### Facility Snapshot/Description

The Caldwell County Detention Center (CCDC) is owned and operated by Caldwell County under the supervision of the Sheriff. The facility is located in Kingston, Missouri, a rural community approximately one hour north of Kansas City. The indirect supervision facility houses housed

The facility houses detainees in two 14-bed pods, two 24-bed pods and a 48-bed dormitory. The control center is centrally located and provides indirect supervision as well as camera surveillance. Officers make rounds and conduct wellness checks on a routine basis. Detainees may contact the control center by using the intercom system.

Detainees spend the majority of their time socializing in the dayroom, watching television, playing cards, reading and using the kiosk. The outdoor recreation area is adjacent to the housing units. Several detainees complained about the lack of recreation equipment in the outdoor recreation area. It was determined that the area had previously been equipped with a pull-up bar and a basketball hoop. Both were removed due to detainees damaging them. The facility provides a leisure library that contains a large selection of reading materials for the detainees.

The inspection team visited the housing units several times during the inspection and all detainees were interviewed. During interviews the detainees voiced no substantive complaints. All of them stated that they felt safe in the facility and that the officers treat them with respect and are responsive to their requests. Detainees stated that ICE officers visit the housing units every week and that they respond to their questions and requests. Two detainees complained that it was difficult to hear on one of the telephones as other conversations could be heard on the lines. When questioned they stated that they had not advised facility personnel about the problem. The issue was reported to the assistant administrator who notified the telephone service provider.



The facility cleanliness was observed to be average.

The setting is that of a typical jail, making the concepts of civil detention difficult to incorporate into the daily operation. During the inspection ICE detainees were being housed with non-ICE detainees. Facility staff stated that they do try to house ICE detainees in a separate housing unit if the space is available and the detainees have compatible classification designations. Facility personnel encountered during the inspection were professional and cordial and it was noted that detainees approached them without hesitation.

Medical services are provided by Advanced Correctional Health Care. Food services are provided by Catering By Marlins (CBM). ICE detainees do not incur medical co-payments.

## Areas of Concern/Significant Observations

There were no areas of concern identified during this inspection.

### **Recommended Rating and Justification**

The Lead Compliance Inspector recommends that the facility receive a rating of Acceptable. The facility complies with the ICE National Detention Standards (NDS). No (0) standards were found Deficient and two (2) standards were Not Applicable (N/A). All remaining thirty-seven (37) standards were found to be Acceptable.

The findings of Acceptable and Deficient are accurately and completely documented on the G-324A Inspection Form and are supported by documentation in the inspection file.
