The Nakamoto Group, Inc. performed an annual inspection for compliance with the ICE National Detention Standards (NDS 2000) of the Cambria County Prison, Edensburg, PA, during the period of November 5-7, 2019. This is an IGSA facility.

### **Type of Inspection**

This is a scheduled annual inspection, which is performed to determine overall compliance with the ICE NDS 2000 for Over 72 hour facilities. The facility received a previous rating of Acceptable during the November 2018 inspection.

The inspection team identified two (2) deficient components in the following two (2) standards:

- Admission and Release - 1, which is a repeat deficiency
- Correspondence and Other Mail - 1, which is a repeat deficiency

### Facility Snapshot/Description

The Cambria County Prison is a [REDACTED] direct supervision facility located in Ebensburg, PA. The facility is governed by the Cambria County Prison Board, which is made up of three county commissioners, the sheriff, the district attorney, the controller and the president judge. The facility houses adult male and female detainees for ICE, the U.S. Marshal Service and local and state jurisdictions. [REDACTED]

[REDACTED] There were no female ICE detainees housed at the facility during the inspection. [REDACTED]

The housing units provide adequate open space and detainees were observed socializing in the dayrooms and watching television. Detainees have access to telephones, board games, a leisure library and a microwave in the dayrooms. The atmosphere was calm and detainees approached the inspection team without hesitation.

ICE detainees are commingled with other populations of similar classification custody levels. The dormitory style and cell type housing units where ICE detainees are detained were observed to have an acceptable level of sanitation. There were several temporary beds (boats) observed on the floors in two different housing units. According to supervisors and officers interviewed, ICE detainees are never assigned to these temporary beds. Interviews with detainees confirmed this practice. An inspection of the facility overall reflected a positive environment, acceptable conditions, and no issues being noted with the conditions of confinement.

There was a total of 36 interviews conducted with detainees. Confidential interviews were conducted with eight LEP detainees by a bilingual inspector. There were also eight confidential detainee interviews conducted with English speaking detainees. All the detainees interviewed stated that they were receiving services, were offered recreation frequently and did not fear for their safety. The detainees stated they were treated with respect by staff. All detainees interviewed stated that they have had frequent contact with the assigned ICE officer. One detainee claimed that he had a brain tumor removed prior to his admission to the facility; that he was still suffering from headaches and told the inspector that he had made a sick call request four days prior to the interview, but still had not seen the doctor. The medical SME followed up on the complaint and found that there was no record of the detainee having a brain tumor removed. The detainee was also examined by the facility's medical staff who had no record of his claim. The staff also found no visible signs indicative of a surgical procedure to remove a tumor. Staff did treat the detainee for his headache. Another detainee claimed that the facility's LexisNexis application was a 2010 version of the application. An inspector and a counselor explained to the detainee that the 2010 date on the application was the copyright date and that application was last updated in September 2019.

The facility does not charge co-pays for medical, mental health or dental care. Health services are provided by PrimeCare Medical. All other services are provided by Cambria County employees.

### **Areas of Concern/Significant Observations**

There were no areas of concern or significant observations noted during the inspection.

### **Recommended Rating and Justification**

The Lead Compliance Inspector recommends that the facility receive a rating of Acceptable. The facility complies with the National Detention Standards (NDS) 2000 for Over 72 hour facilities. No (0) standards were found Deficient and one (1) standard was Not Applicable (N/A). All remaining thirty-eight (38) standards were found to Meet Standards.
