Type of Inspection

This is a scheduled annual inspection, which is performed to determine overall compliance with the ICE NDS for Over 72 hour facilities. The facility received a previous rating of Acceptable during the April 2018 inspection.

Facility Snapshot/Description

The Dodge County Detention Facility (DCDF) is located in Juneau, Wisconsin, approximately sixty miles northwest of Milwaukee. The facility is operated by the Dodge County Sheriff's Office. The county has an Intergovernmental Service Agreement (IGSA) with ICE to house male and female detainees. [REDACTED]

Housing units are comprised of two direct supervision pods, two indirect supervision pods and one dormitory pod. The flexible housing options ensure that detainees are housed according to their respective classification levels. The Phase System, which works in conjunction with the ICE classification level system, is designed to provide incentives for positive behavior, as well as, program and work opportunities. The facility houses all ICE classification levels. ICE detainees are housed with other jurisdictions.

The housing units provide adequate open space. The common areas are furnished with televisions, commissary and program request kiosks, telephones, facility information binder (color-coded for ICE detainee services) and game tables. The atmosphere in the housing units was relaxed and detainees openly communicated with the inspection team. The inspection team interviewed approximately eighty detainees. Detainees stated, without exception, that they felt safe and had no concerns regarding programs and services. Facility staff were observed using the Language Line to communicate with detainees. Interviews with LEP detainees indicated that they had no issues communicating with staff and no problems obtaining services. There were no concerns expressed about medical services, law library privileges or conditions of confinement. Detainees were observed working in food services, cleaning in the pods, playing board games, playing cards, watching television, exercising in the indoor recreation area, teleconferencing in a private multipurpose room and reading. There is a law library adjacent to each housing unit.



Facility employees conducted themselves professionally during all interactions with the inspection team and with detainees. Sanitation levels were observed to be above average. Medical services are provided by WellPath. ICE detainees do not pay medical co-payments. Food services are contracted to Aramark.

Areas of Concern/Significant Observations

There were no areas of concerns or significant observations.

Recommended Rating and Justification

The Lead Compliance Inspector recommends that the facility receive a rating of Acceptable. The facility complies with the ICE National Detention Standards (NDS). No (0) standards were found Deficient and one (1) standard was Not Applicable (N/A). All remaining thirty-eight (38) standards were found to be in compliance.
