Comments: This inspection was conducted to determine overall compliance with the ICE Performance-Based National Detention Standards 2011 (42 standards), which include the following additions/changes to the standards listed on page three:

- Medical Care (Women), a new standard, was Not Applicable;
- Classification System is now titled Custody Classification System;
- Suicide Prevention and Intervention is now titled Significant Self-Harm and Suicide Prevention and Intervention;
- Escorted Trips for Non-Medical Emergencies is now titled Trips for Non-Medical Emergencies;
- News Media Interviews and Tours is now titled Interviews and Tours, and;
- Transfer of Detainees is now titled Detainee Transfer.

There were no SAAPI allegations during the inspection period. There were no escapes, use of force incidents or serious suicide attempts during the inspection period. The facility does not have a canine unit nor do they use Tasers. The only chemical agent authorized for use is pepper spray. Only ICE personnel are authorized to use chemical agents.

During the inspection period, there was one reported death. A 54-year-old Mexican male was admitted 2/26/2019. At the time of admission, vital signs were within normal limits. He reported having diabetes for three years. He denied a mental health history, use of tobacco or alcohol. The detainee was assessed with diabetes, restless leg syndrome and toenail fungus. The detainee was evaluated for the diabetes, medication was prescribed and lab work ordered. Lab results indicated normal cholesterol and triglyceride levels and a slightly elevated Hemoglobin A1c. The detainee was evaluated in sick call for sore feet on 3/4/2019. On 3/7/2019, he was evaluated in the diabetic chronic care clinic. On 3/25/2019 he received a 90-day follow-up physical examination. On 3/28/2019 he was evaluated in sick call for pain in both feet. On 4/1/2019 the detainee was evaluated during sick call for flu-like symptoms. Medication was

prescribed, and the detainee was placed on medical observation in the administrative segregation unit. The detainee was evaluated by an RN at 5:58 a.m. on 4/2/2019. The detainee was re-evaluated at 3:02 p.m. by an RN who notified a mid-level provider that the detainee had an abnormally low blood-oxygen saturation level. At 6:12 a.m. on 4/3/2019, the administrative segregation officer contacted the medical department to relay that the detainee needed assistance. Two RNs responded. Prior to their arrival, security officers began CPR. Upon arrival on scene, the RNs took over CPR, requested an AED and ordered that paramedics be called. The AED indicated "shock not advised" and CPR was continued. Paramedics arrived on scene at 6:23 a.m. and took over CPR. Paramedics stopped CPR and pronounced the detainee dead at 6:33 a.m. The medical examiner was contacted who arrived onsite at 7:43 a.m. and examined and transported the body. Autopsy results are pending, and the death remains under investigation.
