The inspection team identified thirteen (13) deficient components in the following seven (7) standards:

Correspondence and Other Mail – 1, which is a repeat deficiency Detainee Handbook- 1 Food Service – 3, one of which is a repeat deficiency Hunger Strikes – 2, one of which is a repeat deficiency Terminal Illness, Advanced Directives and Death – 3, all of which are repeat deficiencies Key and Lock Control- 2 Tool Control- 1

## Facility Snapshot/Description

The Frederick County Detention Center is owned and operated by the Frederick County Sheriff's Office. The facility is located in the southern part of Frederick, Maryland, surrounded by other county entities and commercial properties. The facility houses adult male and female Frederick County detainees and low security adult male ICE detainees. The facility does not house administrative, disciplinary, or protective custody status ICE detainees, or those that would be placed in the SMU for any reason. Detainees developing such a need while housed at the facility are transferred to another facility immediately. The exterior perimeter of the compound is comprised of outer walls and a twenty-foot-high chain linked fence, capped with razor ribbon. The perimeter is checked by a supervisor at least twice each shift. There is significant camera coverage throughout the facility which provides visual observation of the perimeter and most areas inside the facility.

ICE maintains an on-site pres-

ence at the facility through the 287g program.

There are 21 separate housing units of varying sizes, all consisting of two-person cells. ICE detainees are housed separately from other detainees. They have access to an adjacent outdoor recreation yard for no less than two hours per day. The ICE housing unit provides adequate open dayroom space wherein detainees may watch television, play board games, or walk. Detainees spend the majority of their time during waking hours socializing in the dayrooms or recreating. The atmosphere is free of any obvious tension. Detainees were observed interacting with staff and other detainees. Detainee movement outside of the living area is escorted and orderly.

The inspection team interviewed all ICE detainees during the inspection and conducted fifteen formal detainee interviews. There was a complaint that a telephone was out of order. The telephone was repaired that same day. One detainee complained that the shower water was too hot. The Safety SME measured the temperature and determined that the water was in the range required by the standard. A detainee mentioned that he did not get enough outdoor recreation. The schedule provides a minimum of two hours of outside recreation per day, and observation during the inspection verified this practice. One detainee asked for a microwave to be placed in the housing unit. The standards do not provide for microwave availability to detainees. One detainee stated that the food did not have enough seasoning. The Safety SME verified that the menu and recipes are approved by a dietician. LEP detainees indicated that they had no issues accessing services. Without exception, all detainees expressed that they felt safe at the facility.



Medical services are provided by Wellpath. All other services are provided by Frederick County employees. ICE detainees are not charged medical co-payments.

## Areas of Concern/Significant Observations

There were no areas of concern or significant observations.

#### **Recommended Rating and Justification**

The Lead Compliance Inspector recommends that the facility receive a rating of Acceptable. The facility complies with the ICE National Detention Standards (NDS). No (0) standards were found Deficient and three (3) standards were Not Applicable (N/A). All remaining thirty-six (36) standards were found to be in compliance.

The findings of compliance and non-compliance are accurately and completely documented on the G-324A Inspection Form and are supported by documentation in the inspection file.
