Comments: The Sexual Abuse and Assault Prevention and Intervention Standard was inspected during this inspection, but is not referenced in the Standards Review Summary Report. The standard was rated as Meets Standard for this inspection.

There were no serious suicide attempts or detainee deaths since the previous inspection. The facility reported one allegation of sexual abuse/sexual harassment since the previous inspection. The allegation involved two episodes of ICE detainee on ICE detainee indecent exposure. The allegation did not involve physical assault or penetration. The allegation was investigated by the Hardin County Sheriff's Office and was determined to be substantiated. Criminal charges were filed against the alleged assailant.

There were no escapes or serious attempts since the previous inspection. There were no use of force incidents involving ICE detainees since the previous inspection. Oleoresin capsicum (OC)/pepper spray is available for use by trained staff to control detainees, if necessary. Tasers are available but policy prohibits their use on ICE detainees. Canines are not used to control ICE detainees and they have not been used for searches during this inspection period. The use of choke holds is prohibited.

The data on page two of the Significant Incident Summary Report is for the ICE population only.
