Comments: The Sexual Abuse and Assault Prevention and Intervention Standard was inspected during this inspection but is not referenced in the Standards Review Summary Report. The standard was rated as Meets Standard for this inspection. The information provided on the Significant Incident Summary Worksheet references the ICE detainee population.

There were eleven allegations of sexual abuse or assault during this inspection period. The allegations included one staff on detainee allegation for inappropriate touching during a pat search which was unsubstantiated. Four allegations were detainee on inmate, due to inappropriate touching and verbal gestures. Results of investigations revealed three detainee on detainee allegations were unsubstantiated. Two detainee on detainee allegations for sexual harassment revealed one substantiated and one unfounded. One allegation did not qualify as a PREA violation when referenced to the sexual abuse/assault definition chart. Documentation of facility practice was reviewed and confirmed that reporting, investigation and follow-up was within the guidelines of the standard.

There were no deaths, escapes or serious suicide attempts during the inspection period.

On 06/06/2019, a Suicide/Mental Health Behavior Log was found by the QMC inspector in a detainee's medical file indicating that a detainee had been placed in the restraint chair. However, no other documentation was found regarding the incident. After discussion with facility staff, it was determined an internal investigation would be conducted. Currently there is no medical report, no supervisory report or an incident report. The detainee had been in the special management unit (SMU) since 02/24/2019. On 03/08/2019 he was placed in the restraint chair at 4:57 a.m., released from the chair at 6:00 a.m. and taken to court at 6:12 a.m. He was returned to the

facility later that day and placed back in the SMU to finish serving his disciplinary sanction. The detainee is on the mental health caseload.

There was one immediate use-of-force incident. Oleoresin Capsicum (OC) spray was deployed to gain control of three individuals involved in a fight, including two ICE detainees and one jail inmate. Decontamination was conducted by medical staff. There were no injuries noted and only the least amount of force necessary to control the situation was used. The incident was reviewed by the shift supervisor and the OIC. A review of the use of force packet, including the after-action review, was conducted.

Tasers are carried by trained supervisors; however, use on detainees is prohibited. Canines are not used to control ICE detainees. Only ICE approved restraint equipment is authorized and used to restrain detainees. Chokeholds and unsafe restraining practices are prohibited by policy.
