Facility Snapshot/Description

The LaSalle Correctional Center (LCC) is owned and operated by LaSalle Management Company, LLC and has an intergovernmental services agreement (IGSA) with the LaSalle Parish Sheriff’s Office. The facility is located in a rural area of Olla, Louisiana. [REDACTED]

[REDACTED] LaSalle houses male offenders from the Louisiana Department of Corrections and LaSalle Parish.

The LCC property is accessible by one main road which is barred by a security gate. The gate house is staffed 24 hours a day. The physical plant includes eight dormitories with varying capacities from 61 to 101. The facility is surrounded by an outer twelve-foot fence and inner ten-foot fence. Each outer fence is equipped with razor wire at the top and bottom. The building consists of a linear hallway providing dormitory style housing on both sides of the corridor. The hallway leads to six special management cells, a law library, barber shop and laundry room. The housing units provide a generous amount of open space. Detainees spend the majority of their time socializing in the dayrooms, watching television, playing board games, x-box gaming or participating in outdoor recreational activities on one of four recreation yards. Basketball, soccer and cardiovascular equipment is available on the recreation yards. The special management recreation yard includes a television. Detainees are permitted recreation a minimum of one hour per day seven days a week. Food service operations are provided in a dining hall with a seating capacity of 125, serving three hot meals per day under the direction of a licensed registered dietician.

An inspection of the housing units, medical unit, and the facility overall reflected a positive environment with average sanitation conditions being observed. No less than 115 detainee interviews were conducted. Detainees were interviewed in the special management unit, dining hall and general population housing units. Formal interviews were conducted with the language line in a confidential setting. Each detainee stated that he felt safe. All stated that they were treated respectfully by the officers and were receiving services required by the standards. There were no concerns noted regarding medical services, legal services or communication with ICE officers. One detainee complained that recreation was not offered every

day. A review of records confirmed that recreation was offered every day during the inspection period. One detainee complained that fresh fruit is not served. A review of the menus confirmed that all meals meet the minimum daily dietary requirements.

The facility does not charge a copayment for medical, mental health or dental care services. All services are provided by LaSalle employees.

Areas of Concern/Significant Observations

There were no areas of concern observed during the inspection.

Recommended Rating and Justification

The Lead Compliance Inspector recommends that the facility receive a rating of Meets Standards. The facility complies with the ICE Performance Based National Detention Standards (PBNDS 2011) for Over 72 hour facilities. No (0) standards were found Does Not Meet Standards. Forty (40) standards were found to Meet Standards and two (2) standards were Not Applicable (N/A).
