Comments: This inspection was conducted to determine overall compliance with the ICE Performance-Based National Detention Standards (PBNS 2011) which include the following additions/changes to the standards listed on page three:

- Medical Care (Women), a new standard, was rated Meets Standard;
- Classification System is now titled Custody Classification System;
- Suicide Prevention and Intervention is now titled Significant Self-Harm and Suicide Prevention and Intervention;
- Escorted Trips for Non-Medical Emergencies is now titled Trips for Non-Medical Emergencies;
- News Media Interviews and Tours is now titled Interviews and Tours, and;
- Transfer of Detainees is now titled Detainee Transfer.

There were eight allegations of sexual abuse/assault since the last inspection; two were determined to be unfounded, four unsubstantiated, one substantiated, and one investigation is ongoing. Six of the allegations were detainee-on-detainee and two were staff-on-detainee. The alleged behaviors ranged from inappropriate touching to verbal harassment incidents. One staff-on-detainee allegation involved inappropriate touching which was unfounded. The other staff-on-detainee allegation involved inappropriate touching and verbal harassment which was unsubstantiated. One detainee-on-detainee allegation involving verbal comments of a sexual nature was substantiated. None of the cases involved oral, anal, or vaginal penetration or attempted penetration. All the case files were reviewed; procedures conducted by medical and detention staff were found to comply with the requirements of the standard.

There were six immediate use of force incidents and no calculated uses of force during this inspection period. Four of the immediate uses of force involved male detainees and the other two incidents involved female detainees. A review of documentation and video substantiated that all use of force incidents were conducted in accordance with established policy and procedures. Medical evaluations were conducted in all incidents in a timely manner. In five of the six immediate use of force incidents, the detainee involved refused to return to his/or her assigned housing unit from the medical department and the sixth incident consisted of an inmate on inmate fight. Other than minor bruises, there were no injuries to staff or detainees in any of these incidents. In all incidents, except for one incident in which chemical agents were used, only the use of hand restraints was required to take control of the detainee. After action reviews for the six incidents were conducted by the OIC and a review committee.

There were no escapes, deaths or serious suicide attempts during the inspection period. The facility does not have a canine unit for contraband detection. The only chemical agent in the facility is OC (oleoresin capsicum)/pepper spray. The use of unsafe types of force such as choke holds, carotid control holds and neck restraints are not authorized. Tasers are not used.
