Facility Snapshot/Description

The Natchitoches Parish Detention Center is a [REDACTED] IGSA facility operated under the jurisdiction of the Natchitoches Parish Sheriff's Office. The facility is located in Natchitoches, Louisiana, approximately sixty miles northwest of Alexandria, Louisiana. [REDACTED]

[REDACTED] The facility began housing ICE detainees in July of 2018 and this is the first inspection of the facility.

The facility was originally constructed in 1995 with an additional cell block, L-Dorm, constructed in 2000. L-Dorm has 124 beds in four housing units and is where a number of ICE detainees are housed. L-Dorm also contains the Special Management Unit (SMU), although no ICE detainees have been housed in the SMU in the previous twelve months. ICE detainees are also housed in two other housing units with other ICE detainees of like security classification levels. All housing units consist of open bay housing and there is indirect supervision with roving officers and control rooms with control room staff monitoring cameras. Each housing unit consists of a dayroom area with tables/chairs, a television, a bank of telephones, board games/cards, and enough showers and wash basins to serve the capacity of the unit.

All staff were professional and cordial to the inspection team. None of the personnel interviewed were well versed in the National Detention Standards nor did they have a good understanding of the concept of civil detention.

The inspection team visited the housing units several times during the inspection and interviewed no less than fifty detainees in groups and twenty detainees in a private setting. Ten of the interviews in a private setting were conducted with LEP detainees by a bilingual inspector. They registered no substantive concerns from detainees on health care, treatment by staff, participation in programs and activities, access to ICE, or conditions of confinement. Detainees stated that ICE personnel are available and responsive to their requests. LEP detainees stated they have no problem communicating with staff.

Detainee telephone services are provided by Ally Telecom Group and food services are provided by Aramark. All other services are provided by Natchitoches Parish employees. The facility does not charge co-pays for medical, mental health, or dental care.

Recommended Rating and Justification

The Lead Compliance Inspector recommends that the facility receive a rating of Does Not Meet Standards. The facility does not comply with the ICE Performance Based National Detention Standards (PBNDS) 2011. Seven (7) standards were found Does Not Meet Standards and three (3) standards were Not Applicable (N/A). All remaining thirty-two (32) standards were found to Meet Standard.
