Comments: This inspection was conducted to determine the overall compliance with the ICE Performance-Based National Detention Standards (PBNDS) 2011. The following are the PBNDS 2011 additions/changes to the standards listed on page three:

- Medical Care (Women), a new standard, was rated Not Applicable (N/A);
- Classification System is now titled Custody Classification System;
- Suicide Prevention and Intervention is now titled Significant Self-Harm and Suicide Prevention and Intervention;
- Escorted Trips for Non-Medical Emergencies is now titled Trips for Non-Medical Emergencies;
- News Media Interviews and Tours is now titled Interviews and Tours;
- Transfer of Detainees is now titled Detainee Transfers

There was one SAAPI allegation during this inspection period. Multiple detainees reported to staff that a detainee in their unit was sexually harassing another young male detainee. The detainees were separated and the allegation was investigated, and substantiated. The perpetrator was moved to a different housing unit.

There were no deaths or serious suicide attempts during this inspection period.

There were six uses of force involving ICE detainees. Two were calculated uses of force. One was a cell extraction to remove a detainee from a medical cell for placement in the Special Management Unit (SMU). The other involved the removal of two detainees from a SMU cell due to toxic smoke, after they had set the plastic shower curtain on fire. A review of videos and use of force reports indicated that force was applied within guidelines of the standard. The remaining four uses of force were immediate uses of force. Of those instances, two involved detainees resisting. A third was for resisting and assault. Reports indicated that force was applied within guidelines of the standard. The medical evaluations were timely. The fourth was for resisting and attempted escape from a housing unit pod. A review of the use of force reports of this incident by the incident review board concluded that, after placing the detainee in

a cell in the SMU and retrieving the handcuffs, the detainee began beating on the cell door, was instructed to stop but continued. The supervisor returned to the cell, opened the food trap door, and administered a burst of Oleoresin Capsicum (OC) spray to the chest and facial area of the detainee. The review board determined that the use of the OC spray was not justified. Also determined in the review was a lapse in time between the detainee being sprayed with the OC and being taken to medical for decontamination and assessment. It was noted; however, that a shower is in the SMU cell the detainee was placed in. A recommendation was made for disciplinary action along with in-service training to ensure future compliance. The OIC concurred with the recommendations, and appropriate action was taken. The detainees involved in the uses of force received no injuries.

Oleoresin Capsicum (OC)/pepper spray is authorized for use to control detainees, if necessary. Canines are authorized for contraband detection, but not in the presence of detainees. Tasers and restraint chair are not authorized for use to control detainees.
