Facility Snapshot/Description

The Shawnee County Department of Corrections, Adult Detention Center (ADC) is owned by Shawnee County and governed by the Board of County Commissioners. The facility is located approximately eighty miles west of Kansas City in the Topeka, Kansas business district. The facility houses adult males and females for the City of Topeka, U.S. Marshals Service, Kansas Department of Corrections, ICE and Shawnee County. No female ICE detainees have been housed at the facility during the inspection period.

The facility houses all custody level ICE

detainees. Both detainees were interviewed. Both detainees spoke English. One detainee complained that obtaining telephone time is difficult. Detainees are required to complete a telephone request slip to use the telephone. The detainee stated that "all officers do not follow the required procedure". The compliance captain stated that she would follow up on the concern. Detainees had no concerns with library services, medical services, visitation, or food services. According to the program officer, ICE detainees are permitted to participate in the Thrive Drug and Alcohol program and Real Talk for Men.

The entire perimeter is under camera surveillance which is continuously monitored by central control officers. All exterior doors are alarmed. The ADC physical plant includes fourteen modules (housing units). The ADC consists of four floors. The first and third floors are used for housing units. The second and fourth floors are used for video visitation. The annex is used to house detainees when necessary. The annex is a stand-alone building consisting of two housing units on one floor with attached recreation areas. Staff were professional in appearance and attitude and demonstrated a working knowledge of standard requirements. Dayroom activities



include watching television, playing cards, reading, and talking on the telephone. Detainees were observed participating in outdoor recreation.

Medical services are contracted to Corizon Health. Detainees do not have a copayment. Food services are provided by Aramark. All other services are provided by Shawnee County employees. Cleanliness and sanitation was observed to be above average.

Areas of Concern/Significant Observations

There were no areas of concern or significant observations.

Recommended Rating and Justification

The Lead Compliance Inspector recommends that the facility receive a rating of Acceptable. The facility complies with the ICE National Detention Standards (NDS). No (0) standards were found Deficient and three (3) standards were Not Applicable (N/A). All remaining thirty-six (36) standards were found to be in compliance.
