The Nakamoto Group, Inc. performed an annual inspection for compliance with the ICE National Detention Standards (NDS) of the Tallahatchie County Correctional Facility in Tutwiler, Mississippi, during the period of August 13-15, 2019. This is an IGSA facility.

### **Facility Snapshot/Description**

The Tallahatchie County Correctional Facility (TCCF) is owned and operated by CoreCivic. The single story, concrete structure is located on 149 acres in rural Tutwiler, Mississippi with 65 acres located within the fences. The perimeter is patrolled 24 hours a day. The [REDACTED] direct-supervision facility houses male and female detainees for local jurisdictions, and male detainees for the U. S. Marshals Service, ICE, the States of Vermont, South Carolina, and Vermont and the Virgin Islands DOC. [REDACTED]

The facility currently houses low custody male ICE detainees. ICE detainees are not comingled with detainees from other jurisdictions. General population detainees are permitted to be out of their cells the majority of the day, socializing in the dayroom or enjoying other indoor recreational activities. The dayrooms are equipped with televisions, cards, board games, and telephones. A leisure library with a large selection of books is available for detainee use. Detainees have access to an indoor gymnasium and three outdoor recreation yards. Exercise programs and activities are delivered within the parameters of a safe, secure and orderly operation. Outdoor activities are limited to handball, basketball, volleyball, soccer and cardiovascular activities.

The inspection team visited the detainee housing units' numerous times during the inspection observing detainees interacting with each other and with facility staff. Detainees were relaxed and spoke to the inspectors without hesitation. LEP detainees were interviewed in private via a telephonic translation service in Spanish, Bengalese, Tamil (Sri Lanka) and Mandarin. English speaking detainees were interviewed in groups or in a private, confidential setting. The detainees voiced no concerns regarding their safety and stated they are treated with respect by facility staff and other detainees. The only complaints regarding food were that it does not have enough spices and several detainees complained that meat is served too often. There were no complaints regarding medical care.

A fire drill was conducted during the inspection and 22 detainees were evacuated from one housing unit. Observance of the drill indicated that staff were well trained in how to conduct a fire drill.

During this inspection, five housing units were cohorted, affecting 344 ICE detainees. There was one confirmed case of mumps and five confirmed cases of varicella.

Food service operations are provided by Trinity Services Group. All other services are provided by CoreCivic. The facility does not charge co-pays for medical, mental health or dental care. Sanitation throughout the facility was observed to be good.

**Areas of Concern/Significant Observations**

There were no areas of concern or significant observations during this inspection.

**Recommended Rating and Justification**

The Lead Compliance Inspector recommends that the facility receive a rating of Acceptable. The facility complies with the ICE National Detention Standards (NDS) for Over 72 hour facilities. No (0) standards were found Deficient and two (2) standards were Not Applicable (N/A). All remaining thirty-seven (37) standards were found to be in compliance.
