Facility Snapshot/Description

The Willacy County Regional Detention Facility, owned by Willacy County and operated by Management & Training Corporation (MTC), is located in Raymondville, Texas; approximately 240 miles south of the San Antonio International Airport, in San Antonio, Texas, and twenty miles north of Harlingen, Texas.

No ICE detainees were housed at the facility during the inspection nor were any ICE detainees housed at the facility during the twelve months prior to the inspection. According to the facility's OIC, ICE detainees were removed in June 2018 due to an increased demand for beds for the U.S. Marshals Service.

The facility is a one-story building surrounded by a dual perimeter fence supplemented with razor wire and pressure sensors. There is a paved road circling the perimeter of the facility which is patrolled around the clock by an armed officer in a vehicle. The facility has thirty general population housing units with capacities ranging from five to 54 beds. Both cell and dormitory style beds are available. The general population housing units receive indirect supervision from roving officers. Each housing unit is equipped with tables and seats, a television, telephones, and board games. If ICE detainees are housed at the facility, they will be offered recreation at least one hour a day, seven days a week. The facility has two large outdoor recreation yards equipped with stationery exercise equipment, water, and toilet facilities. The designated restricted housing unit contains twenty single cells.

The inspection team observed the housing units and common areas of the facility during the inspection; cleanliness and sanitation were average.

No ICE detainees were housed at the facility during the inspection; therefore, no detainees were interviewed.

Detainee telephone services are provided by ICSolutions. Commissary services are provided via a contract with Keefe Group. All other services are provided by MTC.

ICE detainees would not incur medical co-pays.

Areas of Concern/Significant Observations

There were no areas of concern or significant observations.



Recommended Rating and Justification


The Lead Compliance Inspector recommends that the facility receive a rating of Acceptable. The facility complies with the ICE National Detention Standards. No (0) standards were found Deficient and three (3) standards were Not Applicable (N/A). All remaining thirty-six (36) standards were found to be in compliance.
