Facility Snapshot/Description

The Willacy County Regional Detention Facility is a [REDACTED] facility owned by the county and operated by Management & Training Corporation (MTC). The facility is located in Raymondville, Texas and houses male and female U.S. Marshals detainees. Willacy housed ICE detainees in general population (housed separated from the U.S. Marshals detainees) until June 2018. Since then, ICE admissions to Willacy have been for special medical or mental health needs. [REDACTED]

The facility is a single structure one-story building surrounded by a dual perimeter fence supplemented with razor wire and movement detection sensors. There is a paved perimeter road around the entire facility perimeter patrolled by an armed officer 24 hours a day. The facility is designed with twenty-three general population detainee housing units ranging from one-person cells to 54 bed dormitories. The day rooms are furnished with a television, telephones, tables and day room area. Each detainee has a personal property storage drawer. Indoor and outdoor recreation is made available to all populations for at least one hour a day, seven days a week. The outdoor recreational yards have accessible water and toilet facilities. The inspection team toured the



units that housed ICE detainees during the inspection period. The housing units previously used by ICE detainees were observed to be clean, sanitary and in good repair. The toilets and sinks were clean and operational with hot and cold running water. The showers were clean, mold, mildew and rust free, with hot and cold running water. An inspection of the facility overall revealed a positive environment, clean conditions, and no issues being noted with the conditions of confinement. Sanitation levels were excellent.

The detainee housed in the medical isolation room was interviewed by the Medical SME and he had no concerns or issues. When asked if he had been seen by an ICE officer, he stated that he was seen "yesterday" during the inspection. Most of the facility employees are bi-lingual. Facility employees were professional and were knowledgeable of ICE standards.

Medical and food services are provided by Management & Training Corporation. Detainees do not have a medical copayment.

Areas of Concern/Significant Observations

There were no areas of concern or significant observations.

Recommended Rating and Justification

The Lead Compliance Inspector recommends that the facility receive a rating of Acceptable. The facility complies with the ICE National Detention Standards (NDS). No (0) standards were found Deficient and three (3) standards were Not Applicable (N/A). All remaining thirty-six (36) standards were found to be in compliance.
