Until a guaranteed minimum population or Facility Operating Charge (FOC) is reinstated into this agreement by modification, the service provider may, without ICE approval, adjust the number of staff that are deployed consistent with fluctuations in the number of ICE detainees that are assigned to the facility. The service provider will continue to submit to the COR the vacancy reports that are required in Article 2, paragraph E of this IGSA; however, until this agreement is modified to reinstate a guaranteed minimum population or FOC, the service provider will not be subject to minimum staffing levels, the obligation to fill positions within 120 days, or deductions delineated in the agreement in regards to vacancies (including in Article 2, paragraph E). The parties agree that any guaranteed minimum population or FOC will be commensurate with the contract staffing plan and will be memorialized by mutually agreed modification.
