<b>PRESUMPTIVE TESTING DESIGNATED POSITIONS</b>			
1801	Law enforcement personnel (multiple positions)	Investigate and act on violations of immigration law: arrest violators, manage cases, and ultimately remove or release aliens from custody.	Personnel carry firearms or have law enforcement sensitive positions.
1802	Law enforcement personnel (multiple positions)	Detention and transportation of aliens in custody.	Position is required to carry a firearm.
1811	Criminal investigator	Enforce or investigate violations of law of a criminal, civil, or administrative nature, including investigations of employee misconduct.	Position is required to carry a firearm.
Multiple series		Serve in driver roles or on flight crews.	Drug use is incompatible with the safe operation of aircraft and vehicles.

**PREFERRED TESTING DESIGNATED POSITIONS**

All personnel with a top secret or higher clearance, regardless of position, will be tested based on “access to sensitive information.” These positions include:

0080	Security Administration: personnel security specialist; physical security specialists; administrative security	Maintain the integrity of the ICE mission and protect personnel, property, and resources.	Positions require access to sensitive information or are responsible for the security of federal facilities and have a clearance of top secret or above.
0132	Intelligence research specialists and intelligence operations specialists	Collect, analyze, evaluate, interpret, and disseminate information that directly and indirectly affects national security.	Position requires access to sensitive information and a clearance of top secret or above.
0905	Attorney	Render legal advice and services for the agency.	Position requires access to sensitive information and a clearance of top secret or above.
1701	Supervisory instructor	Manage and supervise the instructors on course material and training aids.	Position requires access to sensitive information and a clearance of top secret or above.
1712	Training instructor	Instruct personnel with course materials on all types of subject matter.	Position requires access to sensitive information and a clearance of top secret or above.
	Director, Presidential appointments	Senior leadership positions of the agency.	Presidential appointee with Senate confirmation required Executive Order 12564 of September 15, 1986.
