Immigration History

- On February 19, 2020, Mr. CARCAMO, along with his son, were encountered at the Presidio Texas Port of Entry in Presidio, Texas (TX), without entry documents. Mr. CARCAMO and his son were screened and processed by U.S. Customs and Border Protection (CBP) before being transported to Border Patrol Station 1 in El Paso, TX to arrange housing placement.
- On February 21, 2020, CBP transferred Mr. CARCAMO and his son to the Karnes County Residential Center (KCRC).

- **On February 21, 2020**, a registered nurse (RN) completed Mr. CARCAMO's intake screening. Mr. CARCAMO denied having any pain, mental health issues, hospitalizations, taking psychotropic medications, previous suicide attempts, or suicidal ideations. The RN referred Mr. CARCAMO for further evaluation to a physician, dentist, and mental health provider.
- **On February 22, 2020**, an advanced practice provider (APP) completed Mr. CARCAMO's physical assessment, documented normal findings, and instructed Mr. CARCAMO to follow up, as needed.
- **On February 24, March 2 and 9, 2020**, a licensed master social worker (LMSW) completed Mr. CARCAMO's weekly parent audit check and documented normal and negative findings for social, emotional, and/or behavioral problems.
- **On March 5, 2020**, a mental health caseworker (MHCW) observed Mr. CARCAMO during a trauma group session. The MHCW completed Mr. CARCAMO's group assessment and documented his active participation, neatly groomed appearance, calm mood, appropriate affect, and moderate attentiveness; however, Mr. CARCAMO started crying and left the session early. Mr. CARCAMO informed the MHCW he became upset after discussing his experiences and the negative news he received about his case, approximately a week ago. KCRC's chaplain spoke to Mr. CARCAMO and provided additional support. Mr. CARCAMO refused psychiatric services, signed a refusal form, and denied having suicidal ideations.
- **On March 10, 2020**, Mr. CARCAMO attended a stress management group session. An MHCW documented Mr. CARCAMO's minimal participation, neatly groomed appearance,



moderate alertness and appropriate affect. The MHCW documented Mr. CARCAMO did not require any additional referrals.

- **On March 15, 2020**, an APP evaluated Mr. CARCAMO for pain due to a right thigh abscess. The APP ordered an antibiotic and pain-relieving medication.
- **On March 16, 2020**, an LMSW completed Mr. CARCAMO's weekly parent audit check, documented his reports of having anxiety, insomnia (difficulty sleeping), nightmares, and referred Mr. CARCAMO for an individual psychiatric evaluation. The LMSW noted Mr. CARCAMO was alert/attentive, calm, cheerful, but with adjustment problems.

#### Synopsis of Death

- **On March 17, 2020**, at approximately 11:35 p.m., a KCRC resident advisor (RA) looked into Mr. CARCAMO's room window on security rounds but did not observe him. At approximately 11:54 p.m. a nurse entered the room and conducted a wellness check on the child but did not observe Mr. CARCAMO.
- **On March 18, 2020**, at approximately 12:30 a.m., during a security check, an RA noted Mr. CARCAMO was not in his bed and the room lights were off. The RA turned the lights on, opened Mr. CARCAMO's room door, observed Mr. CARCAMO hanging, and announced a medical emergency over the radio.
  - At approximately 12:32 a.m., security and nursing staff entered Mr. CARCAMO's room, observed him hanging from a shower rod with a bed sheet, requested a cut down tool, and activated emergency medical services (EMS) via 911. The nursing staff cut the bed sheet from around Mr. CARCAMO's neck, lowered his body to the floor, initiated cardiopulmonary resuscitation (CPR), and attached an automated external defibrillator. CPR continued until EMS arrived.
  - At approximately 12:42 a.m., EMS arrived on scene, noted Mr. CARCAMO's body was cold to touch, his mouth was difficult to open, and he was in cardiac arrest. EMS intubated Mr. CARCAMO, started intraosseous fluids (a process used to inject medication and fluids directly into the bone marrow), and advanced life-support measures.
  - At approximately 12:55 a.m., EMS pronounced Mr. CARCAMO deceased, after failed resuscitation attempts.
