Immigration History

On November 22, 2023, the U.S. Border Patrol (USBP) arrested Mr. GE near Tecate, CA for entering the United States without admission or parole by an immigration officer.

On November 25, 2023, USBP served Mr. GE a Notice to Appear (NTA), charging him with inadmissibility as an alien present in the United States without being admitted or paroled. On the same date, USBP released Mr. GE on an Order of Recognizance.

On January 24, 2025, Enforcement and Removal Operations (ERO) Philadelphia encountered Mr. GE at the Dauphin County Prison (DCP) in Harrisburg, PA and lodged an Immigration Detainer with the facility.

On July 31, 2025, ERO Philadelphia arrested Mr. GE upon his release from DCP and detained him at the Moshannon Valley Processing Center (MVPC) in Philipsburg, PA.

Criminal History

On January 23, 2025, the Lower Paxton Township, PA, Police arrested Mr. GE for access device issued to another who did not authorize use, conspiracy – access device issued to another who did not authorize use, theft by deception – false impression, conspiracy – theft by deception, criminal use of a communication facility, and unlawful use of computer – access to disrupt function.

On July 31, 2025, the Court of Common Pleas of Dauphin County, PA, convicted Mr. GE of access device issued to another who did not authorize use and conspiracy – access device issued to another who did not authorize use. The Court sentenced Mr. GE to incarceration for a period of six to twelve months with credit for time served.

Synopsis of Events

On August 1, 2025, a licensed practical nurse (LPN) completed Mr. GE's intake assessment using a Mandarin language interpreter. The LPN documented Mr. GE arrived without a DCP medical transfer summary or medications at intake, and documented his denial of any past medical or mental health conditions, denial of medication usage, and released him to the general population.



On August 5, 2025, at approximately 05:20 a.m. EDT, MVPC Detention Officer (DO) found Mr. GE with a cloth ligature around his neck in a shower stall, immediately called for assistance via his radio, and additional MVPC staff responded.

- **At approximately 5:25 a.m.**, MVPC staff utilized a cut down tool to remove the bed sheet tied around Mr. GE's neck, placed him on the floor, and began life saving measures including cardiopulmonary Resuscitation (CPR) and utilizing an Automated External Defibrillator.
- **At approximately 5:31 a.m.**, MVPC staff called 911 and requested Emergency Medical Services (EMS).
- **Approximately 5:35 a.m.**, MVPC staff contacted the Pennsylvania State Police (PSP).
- **At approximately 5:44 a.m.**, EMS staff arrived and took over life saving measures including administering CPR.
- **Approximately 6:03 a.m.**, EMS stopped live saving measures after the Clearfield County, PA Coroner pronounced Mr. GE deceased.
- **Approximately 6:04 a.m.**, PSP arrived in C-unit.
