Immigration History

On January 2, 1988, Mr. NOVIELLO was admitted into the U.S. at Champlain, New York as a B-2 visitor for pleasure.

On September 27, 1988, Mr. NOVIELLO adjusted his status to that of a Conditional Resident.

On October 24, 1991, Mr. NOVIELLO's immigration status was adjusted to that of a Lawful Permanent Resident.

On May 15, 2025, Enforcement and Removal Operations (ERO) Miami apprehended Mr. NOVIELLO at the Florida Department of Corrections Probation office in Daytona Beach, Florida and issued Mr. NOVIELLO a Notice to Appear, Service Form I-862, charging removability pursuant to Section 237(a)(2)(B)(i) of the Immigration and Nationality Act. On the same date, ERO Miami detained Mr. NOVIELLO at the Krome Service Processing Center (KSPC).

On May 19, 2025, ERO Miami transferred Mr. NOVIELLO to Federal Bureau of Prisons (BOP) Federal Detention Center (FDC) in Miami, Florida pending removal proceedings.

Criminal History

On October 12, 2023, the Seventh Judicial Circuit Court in and for Volusia County, Florida convicted Mr. NOVIELLO for the offenses of racketeering, trafficking in Oxycodone 7-14 Grams, trafficking in illegal drugs 4 to 14 Grams, trafficking in Hydrocodone, and unlawful use of a two-way communication device to facilitate commission of crime. The Court sentenced Mr. NOVIELLO to 12 months of imprisonment.

Synopsis of Events

On May 16, 2025, a KSPC advanced practice provider (APP) documented Mr. NOVIELLO's diagnoses of unspecified convulsions and hypertension, and placed him on anticonvulsant and blood pressure medications.

At 4:15 p.m., a registered nurse completed Mr. NOVIELLO's medical intake screening, documented his current diagnoses of hypertension and seizure disorder, slightly elevated blood



pressure, high body mass index, his reported medication list and sent a provider referral for Mr. NOVIELLO.

On May 19, 2025, a behavioral health provider (BHP) addressed Mr. NOVIELLO's referral and recommended a medical provider evaluate him then refer him to mental health if needed.

- **On the same date**, Mr. NOVIELLO was transferred to FDC Miami.

On May 20, 2025, an FDC Miami provider evaluated Mr. NOVIELLO and documented normal vitals except for elevated heart rate and abnormal blood pressure. The provider continued his medications as prescribed at KSPC, and ordered labs.

On May 30, 2025, a provider documented Mr. NOVIELLO refused a health history and a physical exam.

On June 8, 2025, a provider evaluated Mr. NOVIELLO, at the request of a unit officer and health services administrator, to assess his current health status. The provider requested a mental health referral and documented Mr. NOVIELLO reported feeling sad and depressed, and refused to go to the medical clinic for an evaluation.

On June 9, 2025, a provider evaluated Mr. NOVIELLO, by request of a BHP, and documented Mr. NOVIELLO maintained poor personal hygiene and stated he had not eaten in "a while." The APP documented normal vitals, ordered labs, and discussed the importance of self-hygiene and proper diet.

On June 23, 2025, at 12:54 p.m., BOP FDC staff found NOVIELLO unresponsive and declared a medical emergency.

- **At approximately 1:01 p.m.**, medical staff arrived on scene and began administering cardiopulmonary resuscitation (CPR), Automated External Defibrillator (AED) shock, and called 911. Mr. NOVIELLO was transported to the medical clinic on a stretcher. Medical staff continued CPR, documented Mr. NOVIELLO's temperature of 95.5 degrees, blood glucose of 30 milligrams per deciliter [(mg/dL) normal: 70-140 mg/dL], and his continued absence of a pulse, respirations, blood pressure, and oxygen saturation.
- **At approximately 1:09 p.m.**, City of Miami Fire Rescue Department (MFRD) personnel arrived, took over Mr. NOVIELLO's care, and preformed advanced cardiac life support (ACLS) for 30 minutes with no response.
- **At 1:36 p.m.**, MFRD personnel pronounced Mr. NOVIELLO deceased.
