ICE Health Service Corps staff deliver high-quality health care to the detained aliens in ICE custody. We use peer-reviewed guidelines that align with national accreditation standards to diagnose, treat, and maintain quality medical care for aliens at 18 ICE detention centers throughout the country.

For many of these detained aliens, our staff may be their first encounter with medical professionals. ICE Health Service Corps ensures detained aliens receive quality health care at 129 non-IHSC-staffed facilities as well as through off-site specialty and emergency care services.

To be the best health care delivery system in detention and correctional health care.

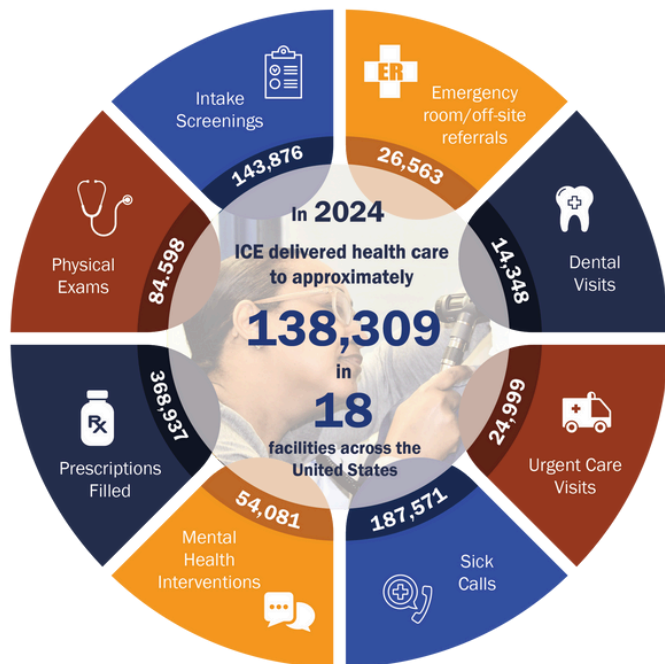
Mission
