INDICTMENT

The Grand Jury Charges:

Count One

Production of Child Pornography
(Violation of 18 U.S.C. §§ 2251(a))

Between on or about September 18, 2008 and July 25, 2009, in the Dallas Division of the Northern District of Texas, and elsewhere, the defendant, **Jerry Wayne Valek**, also known as "Jessica Villerra," employed, used, persuaded, induced, enticed, and coerced John Doe, a person under the age of eighteen (18) years, to engage in sexually explicit conduct for the purpose of producing a visual depiction of such conduct, knowing and having reason to know that such visual depiction would be transmitted using any means and facility of interstate and foreign commerce, and that the visual depiction was transmitted in and affecting interstate and foreign commerce. The visual depictions transmitted by John Doe to **Valek** included the following described lascivious exhibitions of John Doe's genital and pubic area:

File Name	Description
[redacted]21.jpg	A color image of a naked John Doe exposing his erect penis while using a cellular-phone camera to photograph his mirror-image.
[redacted]13.jpg	A color image of a naked John Doe photographing his mirror-image with a cellular-phone camera while holding his penis.
[redacted]22.jpg	A color image of John Doe holding his erect penis in his left hand while taking a photograph of his mirror-image with a cellular-phone camera in his right hand.
[redacted]9.jpg	A color image of John Doe wearing a blue shirt with his underwear pulled down to his thighs, showing him holding his erect penis.
[redacted]5.jpg	A color image of a naked John Doe, standing in a bedroom, exposing his erect penis while standing with his arms flexed behind his head.

In violation of 18 U.S.C. § 2251(a).

Count Two
Production of Child Pornography
(Violation of 18 U.S.C. §§ 2251(a))

Between on or about October 20, 2010 and October 21, 2010, in the Dallas Division of the Northern District of Texas, and elsewhere, the defendant, **Jerry Wayne Valek**, also known as "Jessica Villerra," employed, used, persuaded, induced, enticed, and coerced John Doe II, a person under the age of eighteen (18) years, to engage in sexually explicit conduct for the purpose of producing a visual depiction of such conduct, knowing and having reason to know that such visual depiction would be transmitted using any means and facility of interstate and foreign commerce, and that the visual depiction was transmitted in and affecting interstate and foreign commerce, and the visual depiction transmitted by John Doe II to **Valek** included the following described lascivious exhibition of John Doe II's genital and pubic area:

File Name	Description
23.33.jpg	A color image of John Doe II standing naked in front of a mirror with his erect penis exposed, photographing his mirror-image while flexing his muscles with his hands behind his head.

In violation of 18 U.S.C. § 2251(a).

Count Three
 Production of Child Pornography
 (Violation of 18 U.S.C. §§ 2251(a))

Between on or about December 12, 2010 and December 14, 2010, in the Dallas Division of the Northern District of Texas, and elsewhere, the defendant, **Jerry Wayne Valek**, also known as “Jessica Villerra,” employed, used, persuaded, induced, enticed, and coerced John Doe III, a person under the age of eighteen (18) years, to engage in sexually explicit conduct for the purpose of producing a visual depictions of such conduct, knowing and having reason to know that such visual depiction would be transmitted using any means and facility of interstate and foreign commerce, and that the visual depiction was transmitted in and affecting interstate and foreign commerce. The visual depictions transmitted by John Doe III to **Valek** included the following described lascivious exhibitions of John Doe III’s genital and pubic area:

File Name	Description
[redacted]3.jpg	A color image of a naked John Doe III using a cellular-phone camera in his right hand to take a picture of his mirror-image while holding his penis with his left hand.
[redacted]4.jpg	A color image of a naked John Doe III flexing one arm with his hand behind his head and with his erect penis exposed. John Doe III’s opposing hand is seen holding a cellular-phone camera to take a picture of his mirror-image.
[redacted]5.jpg	A color image of a naked John Doe III exposing his penis while flexing one arm with his hand behind his head while holding a cellular-phone camera in his other hand to take a picture of his mirror-image.

[redacted]7.jpg	A color image of a naked John Doe III with one leg elevated on a sink, exposing his erect penis while photographing his mirror-image with a cellular-phone camera.

In violation of 18 U.S.C. § 2251(a).

Forfeiture Notice
[18 U.S.C. § 2253(a)]

Upon conviction of any or all of the offenses alleged in this indictment and pursuant to 18 U.S.C. § 2253(a), the defendant, **Jerry Wayne Valek**, also known as “Jessica Villerra,” shall forfeit (a) any visual depiction described in 18 U.S.C. § 2252 and any book, magazine, periodical, film, videotape, or other matter which contains any such visual depiction, which was produced, transported, mailed, shipped, or received in the respective offense; (b) any property, real or personal, constituting or traceable to gross profits or other proceeds obtained from the respective offense; and (c) and any property, real or personal, used or intended to be used to commit or to promote the commission of the respective offense and any property traceable to such property.

The above-referenced property subject to forfeiture from the defendant includes, but is not limited to, the following:

- (1) One Apple iPhone, 8 gigabyte model, serial number 87938GXHY7H; and

- (2) One Hewlett Package Pavilion laptop computer, model DV6000, serial number CNF6522VGG.

In violation of 18 U.S.C. § 2253.




