INDICTMENT

The Grand Jury Charges:

Count One

Transportation of Child Pornography and Aiding and Abetting
(Violation of 18 U.S.C. §§ 2252A(a)(1) and 2)

On or about March 14, 2011, in the Lubbock Division of the Northern District of Texas, and elsewhere, **Richard Lee Lewis**, defendant, did knowingly transport child pornography, as defined in 18 U.S.C. § 2256(8)(A), by way of the Internet, a means and facility of interstate and foreign commerce, which child pornography is described as a computer image file entitled "2 yo jackoff dad illegal preteen underage lolita kiddy incest little girl rape anal cum sex lesbian blowjob gay ddoggrpn.jpg," and which image depicts a female child under the age of eighteen (18) years engaging in sexually explicit conduct, specifically: masturbation and lascivious exhibition of the genitals and pubic area of an adult male.

In violation of Title 18, United States Code, Sections 2252A(a)(1) and 2.

Count Two

Transportation of Child Pornography and Aiding and Abetting
(Violation of 18 U.S.C. §§ 2252A(a)(1) and 2)

On or about March 22, 2011, in the Lubbock Division of the Northern District of Texas, and elsewhere, **Richard Lee Lewis**, defendant, did knowingly transport child pornography, as defined in 18 U.S.C. § 2256(8)(A), by way of the Internet, a means and facility of interstate and foreign commerce, which child pornography is described as a computer image file entitled "Alina-NEWSet01-Pict071.jpg," and which image depicts a female child under the age of eighteen (18) years engaging in sexually explicit conduct, specifically: lascivious exhibition of the genitals and pubic area of said child.

In violation of Title 18, United States Code, Sections 2252A(a)(1) and 2.

Count Three

Receipt of a Visual Depiction of a Minor
Engaging in Sexually Explicit Conduct, and Aiding and Abetting
(Violation of 18 U.S.C. §§ 2252(a)(2) and 2)

On or about April 4, 2011, in the Lubbock Division of the Northern District of Texas, and elsewhere, **Richard Lee Lewis**, defendant, did knowingly receive, and attempt to receive, a visual depiction using a means and facility of interstate and foreign commerce, and that had been shipped and transported in interstate and foreign commerce by any means, including by computer, the producing of which involved the use of a minor engaging in sexually explicit conduct, and which visual depiction was of such conduct, that is: an image entitled "Imgscr Ru pthc Pedo Babyshivid childlover Private Daughter Torpedo Ranchi Lolita - 1602942.jpeg," which image depicts a female child under the age of eighteen (18) years engaged in lascivious exhibition of the genitals and pubic area of said child and of an adult male.

In violation of Title 18, United States Code, Sections 2252(a)(2) and 2.

Count Four

Transportation of Child Pornography and Aiding and Abetting
(Violation of 18 U.S.C. §§ 2252A(a)(1) and 2)

On or about April 12, 2011, in the Lubbock Division of the Northern District of Texas, and elsewhere, **Richard Lee Lewis**, defendant, did knowingly transport child pornography, as defined in 18 U.S.C. § 2256(8)(A), by way of the Internet, a means and facility of interstate and foreign commerce, which child pornography is described as a computer image file entitled "PTHC Childlover Ranchi Lolita Pedo 1264723496.jpg," and which image depicts a female child under the age of eighteen (18) years engaging in sexually explicit conduct, specifically: lascivious exhibition of the genitals and pubic area of said child.

In violation of Title 18, United States Code, Sections 2252A(a)(1) and 2.

Count Five
Receipt of a Visual Depiction of a Minor
Engaging in Sexually Explicit Conduct, and Aiding and Abetting
(Violation of 18 U.S.C. §§ 2252(a)(2) and 2)

On or about April 22, 2011, in the Lubbock Division of the Northern District of Texas, and elsewhere, **Richard Lee Lewis**, defendant, did knowingly receive, and attempt to receive, visual depictions using a means and facility of interstate and foreign commerce, and that had been shipped and transported in interstate and foreign commerce by any means, including by computer, the producing of which involved the use of a minor engaging in sexually explicit conduct, and which visual depictions are of such conduct, and are described as follows:

A video file entitled “!Bob! 12 Yo Bitch! Says She Is 14Yo But It’s A Lie! Stickam Shelbzz Chatzppl 2009 08 11.avi”	Masturbation, bestiality, and lascivious exhibition of the genitals and pubic area of a female child under the age of eighteen (18) years.
A video file entitled “Stickam -Rachel-12Yo.avi”	Masturbation and lascivious exhibition of the genitals and pubic area of a female child under the age of eighteen (18) years.

In violation of Title 18, United States Code, Sections 2252(a)(2) and 2.


Count Six

Possession of Child Pornography and Aiding and Abetting
(Violation of 18 U.S.C. §§ 2252A(a)(5)(B) and 2)

On or about May 11, 2011, in the Lubbock Division of the Northern District of Texas, and elsewhere, **Richard Lee Lewis**, defendant, did knowingly possess, and attempt to possess, a Western Digital 250GB computer hard disk drive, serial number WMAV21219084, containing at least one image of child pornography as defined in 18 U.S.C. § 2256(8)(A), that had been mailed, shipped, and transported using any means and facility of interstate and foreign commerce, and in and affecting interstate and foreign commerce by any means, including by computer, and that was produced using materials that had been mailed and shipped and transported in interstate and foreign commerce by any means, including by computer, and which computer hard drive included a child pornography video, among others, entitled "PTHC pedo kid lolita child orkut gotosa buceta bucetuda bunda nua hussyfan pussy brasil brasileira flagra net nifeta safadinha safada menina linda PTSC zoofi.avi," depicting a female child under the age of eighteen (18) years engaging in sexually explicit conduct, specifically: masturbation, and lascivious exhibition of the genitals and pubic areas of said child.




