General Information

The Student and Exchange Visitor Program (SEVP) will deploy the Student and Exchange Visitor Information System (SEVIS) Release 6.64 on Friday, Nov. 18, 2022. This release includes J program enhancements for J school users and program sponsors. Please see the end of this message for system outage details.

J SEVIS enhancements include:

- J-2 forms will print when a J-1 form is reprinted in Transferred status.
- On the Exchange Visitor (EV) Information page, the termination fields are removed if the status changes to Inactive. The page will only display the latest status update data.
- On the EV Information page, the shortened program fields are removed if the status changes to Terminated. The page will only display the latest status update data.
- The Main Supervisor information on a Training/Internship Placement Plan (T/IPP) will not be overwritten.
- The Printed Forms DS-3036 and DS-3037 will display email addresses instead of physical addresses.
- A temporary user will no longer have to enter an Employer Identification Number Date of Issuance when completing a Designation application.
- The responsible officer (RO)/alternate responsible officer (ARO) will receive a Redesignation Application Reminder email six months prior to the program's designation expiration date.
- After a Correct Minor or Technical Infraction is submitted, the before and after values for an email address will display in the EV Event History.
- When the RO/ARO submits a Termination for an EV, a Terminate-User Termination event will display in the EV Event History.
- The Event History will display the Matriculation event detail.

The SEVIS Production environment and SEVIS Batching will NOT be available from Friday, Nov. 18, 2022, 8 p.m. (ET) to Saturday, Nov. 19, 2022, 6 a.m. (ET).
