The Student and Exchange Visitor Program (SEVP) will deploy the Student and Exchange Visitor Information System (SEVIS) Release 6.82 on Friday, April 18, 2025, from 8 p.m. to Saturday, April 19, 2025, at 12 a.m. EDT.

This release includes system fixes for F/M school users and J program sponsors, plus an additional J program enhancement:

- **F/M SEVIS system fix:** The principal designated school official (PDSO) password field for the Form I-17 Update and Recertification submission attestation will allow up to 64 characters.
- **J SEVIS system fix:** For responsible officers (ROs) and alternate responsible officers (AROs), the **Cancel EV** link will not display if an exchange visitor (EV) is in Initial status and the record contains port of entry information.
- **J SEVIS enhancement:** If RO/AROs do not submit a redesignation application three months before the designation expiration date, they will receive an email reminder.

SEVP will deploy SEVIS Release 6.82.1 on Friday, April 25, 2025, from 8 p.m. to Saturday, April 26, 2025, at 12 a.m. EDT.

In accordance with Executive Order 14168, Defending Women from Gender Ideology, Extremism and Restoring Biological Truth to the Federal Government:

- All SEVIS data fields labeled Gender will be changed to Sex.
- The Other option will no longer be available for the Sex data field when creating or updating an Initial F/M student, EV or dependent SEVIS record. If an EV's sex is Other, it must be changed if updates are made on the Biographical Information page.
