### Who is eligible to be a DSO?

Having dedicated employees for assisting and overseeing F and M students is one of several requirements a school must meet to become SEVP certified. Anyone who wants to serve as a [designated school official \(DSO\)](#) must be a regularly employed member of the school's administration. A DSO must be a citizen or lawful permanent resident of the United States.
